### ADVERTISEMENT SIZES

**Trim size of publication: 8-1/8" x 10-7/8"**

#### Non Bleed Sizes      Width x Height

Full Page ..... 7" x 10"  
 2/3 Page ..... 4-5/8" x 10"  
 1/2 Page Horizontal ..... 7" x 4-7/8"  
 1/3 Page Vertical ..... 2-1/4" x 10"  
 1/3 Page Square ..... 4-5/8" x 4-7/8"  
 2-Page Spread ..... 14" x 10"

*For Spread Ads (other than center fold) allow 1/2" dead area in the gutter. Headlines that run across the center seam should be split between words not letters.*

#### Bleed Sizes      Width x Height

Add at least 1/8" to trim side of all edges that bleed. **Keep all live matter at least 3/8" from trim.** If an ad is to bleed, trim marks must be accurately applied.

Full Page Bleed Size ..... 8-3/8" x 11-1/8"  
*Set trim marks at 8-1/8" x 10-7/8"*  
 2-Page Spread ..... 16-1/2" x 11-1/8"  
*Set trim marks at 16-1/4" x 10-7/8"*

Digital material is required. Acceptable file formats are high-resolution PDF (Press Optimized) all fonts embedded. All 4-color images must be CMYK and minimum 300 DPI. **Small text to print in reverse on black, should be on black file only (not 4C).** InDesign files (MAC) may also be provided. Materials submitted in non-standard sizes are subject to rejection or publisher's adjustment.
